COMMITTEE'S REPORT

1.0 Introduction

In early 2013, Malaysian Qualifications Agency (MQA) had conducted a survey to gather feedback on a need for a quality assurance network among higher education institutions (HEI) in Malaysia. The result of the survey led to a session between MQA and Malaysian HEI's quality assurance officials that was held at MQA, Petaling Jaya on 18 September 2013 and was initially chaired by MQA's Chief Executive Officer, YBhg. Dato' Dr. Syed Ahmad Hussein. The meeting had elected a pro tem committee of 14 representatives from Malaysian HEIs and one MQA representative, chaired by Universiti Kebangsaan Malaysia.
